

Privacy Policy Easydek

Easydek Beschermtechniek bv attaches great value to the protection of your personal data. This Privacy Policy provides clear and transparent information regarding how we handle personal data.

We do everything in our power to guarantee your privacy and therefore treat personal data with care. Easydek Beschermtechniek bv adheres to all applicable laws and regulations including the General Data Protection Regulation (AVG). This means that we will in any case:

- Process your personal data in accordance with the purpose for which they were provided, these purposes and types of personal data are described in this Privacy Policy;
- Processing of your personal data is limited to only those details that are minimally necessary for the purposes for which they are processed;
- Asking for your explicit consent if we need it for processing your personal data;
- We have taken appropriate technical and organizational measures to ensure the security of your personal data;
- Not passing on personal data to other parties, unless this is necessary for the execution of the purposes for which they were provided;
- We are aware of your rights regarding your personal data, want to point them out to you and respect them.

Easydek Beschermtechniek bv is responsible for the processing of your personal data. Should you have any questions or wish to contact us after reading our Privacy Policy, or in a more general sense, you can do so via the contact details at the bottom of this document.

Processing of personal data of customers or suppliers

Personal data of customers or suppliers are processed by Easydek Beschermtechniek bv for the following purposes:

- The execution of services, agreements, administration and transactions
- Relationship Management and Communication about the assignment and/or invitations;
- Product and service development;
- Determining strategy and policy;
- If necessary to find out about unlawful behaviour with regard to Easydek Beschermtechniek bv, its relations and its employees;
- The execution or issue of an order. The basis for this

personal data is:

- The agreed assignment.

For the above mentioned purposes Easydek Beschermtechniek bv may request the following personal information from you:

- Names;
- Function(s);

- Gender;
- Address information;
- (Business) Phone Number;
- (Business) E-mail address;
- Chamber of Commerce number and/or VAT number;
- IP address(es);
- Any other data required for the agreement or which you yourself provide us with.

Your personal data will be stored by Easydek Beschermtechniek bv for the duration of the above mentioned processing:

- During the term of the agreement and then only in the financial administration for at least 7 years.

Processing of personal data of Newsletter subscribers

Personal data of newsletter subscribers are processed by Easydek Beschermtechniek bv for the following purposes:

- To inform the person by means of news releases. Basis

for this personal data is:

- The registration form at fairs, registration via advertisement, becoming a customer, registration via the website, telephone registration.

For the above mentioned purposes Easydek Beschermtechniek bv may request the following personal information from you:

- Names;
- E-mail address

Your personal data will be stored by Easydek Beschermtechniek bv for the duration of the above mentioned processing:

- During the period of registration.

Processing of personal data of prospect, stakeholder/lobby contacts and/or interested parties

Personal data of prospect, stakeholder/lobby contacts and/or interested parties are processed by Easydek Beschermtechniek bv for the following purposes:

Providing information in the form of newsletters and/or targeted contacts. Basis for this personal data is:

Verbal consent, issuing a business card and/or via a link on LinkedIn;

For the above mentioned purposes Easydek Beschermtechniek bv may request the following personal information from you:

- Names;
- Gender;
- Function;
- Address information;
- Phone number;
- Email address.

Your personal data will be stored by Easydek Beschermtechniek bv for the duration of the above mentioned processing:

- During the period that one is seen as a prospect, stakeholder/lobby contact and/or interested party.

Provision to third parties

We may provide the information you give us to third parties if this is necessary for carrying out the purposes described above.

For example, we use third parties for:

- Taking care of the internet environment (websites, e-mail);
- Taking care of the (financial) administration;
- Providing newsletters, mailings and invitations.
- Provision of telephone services.

We never pass on personal data to other parties with whom we have not concluded a processing agreement. With these parties (processors) we obviously make the necessary arrangements to guarantee the security of your personal data. Furthermore, we will not provide the data you provided to other parties, unless this is legally required and permitted. An example of this is the police requesting (personal) data from us as part of an investigation. In such a case we must cooperate and are therefore obliged to hand over these data. We may also share personal data with third parties if you give us written permission to do so.

Minors

We only process personal data of minors (persons younger than 16 years) if written permission is given by the parent, caretaker or legal representative.

Storage period

Easydek Beschermtechniek bv does not keep personal data longer than necessary for the purpose for which it was provided or as required by law.

Security

We have taken appropriate technical and organisational measures to protect your personal data against unlawful processing, for example the following measures:

- All persons who are allowed to take cognisance of your details on behalf of Easydek Beschermtechniek bv, are held to confidentiality;
- Our employees are informed about the importance of protecting personal data.
- We maintain a username and password policy on all our systems;
- Spaces are secured with access codes to block physical access to data;
- We pseudonymise and encrypt personal data when appropriate;
- We make backups of the personal data to be able to restore them in case of physical or technical incidents;
- We regularly test and evaluate our measures.

Rights concerning your data

You have the right to inspect, correct or delete personal data that we have received from you. You can also object to the processing of your personal data (or part thereof) by us or one of our processors. You also have the right to have your personal data transferred by us to yourself or on your behalf directly to another party. We may ask you to identify yourself before we can comply with the aforementioned requests.

Should we process your personal data on the basis of a consent given by you, then you always have the right to withdraw this consent.

Complaints

If you have a complaint about the processing of your personal data, please contact us immediately. If we can't work it out with you, it is of course very annoying. You always have the right to submit a complaint to the Netherlands Authority for the Protection of Privacy.
